 - Special Education Evaluation Tool
 - Domain 1
 - Conversation around IEP goals and individualizing to the students' needs
 - How it will look from an evaluators point of view
 - Domain 2
 - Noted 2A had no changes
 - The Sped teacher would be using the IEP more and the goals to drive decision-making for the student
 - Conversation about the lesson development, which teacher did what or are they truly co-planning
